RAMSEY'S GROWTH

YOUTH & COMMUNITY FACILITIES

Whilst Ramsey Youth Centre, the Shed and the facilities at the new infant school provide great services for our young people, there is still room for improvement. I had hoped that the new swimming pool would have incorporated a full community centre servicing all age groups; but this was not to be. However with the support of the people of Ramsey we just might see the old swimming pool housing such facilities.

HOUSING


The availability of affordable housing, particularly for our young people, is a major concern for me. Those who I have spoken to work hard and express a real desire to live in Ramsey but find that they just cannot afford that first step onto the property ladder. There is still a lot that needs to be done to ensure that first time buyers can purchase property within the town.

I am pleased to see the redevelopment of Lezayre Housing Estate coming along, this has been a long process but well worth the wait. We continue to update our existing housing stock in Ramsey, with the installation of new windows and doors and improved insulation.

SOCIAL

I stand firmly with the opinion that more needs to be done in Ramsey to reduce problems with underage drinking and drug use. I fully support the Northern Neighbourhood Policing Team in combating these issues.

You may remember that I was very outspoken against the siting of the Civic Amenity Site at Gardeners Lane and with the support of the local residents we were able to influence the decision to move it elsewhere.
